## Temporary Sign Zoning Permit Application Information

### **General**

A permit application must be completed, submitted to the City, and approved for each temporary sign and prior to the sign being displayed. If any sign is installed or placed on any property prior to receipt of a permit, the specified permit fee shall be doubled and the property owner may be issued a citation which may include a court appearance. All information needs to be provided or the City will deem the application incomplete and the permit will be returned to applicant. The sign location address and **property owner signature** shall be provided on the permit application.

### **Duration**

Signs may not be displayed for more than a total of **90 days per property**, per calendar year. A single permit shall not exceed 30 consecutive days.

### **Sign Location**

Signs must be located on the property of the business and the advertising message must only relate to business conducted on that premises, except that nonprofit or charitable organizations as defined by Internal Revenue Code section 501(C)(3) may have off-premises signs. Nonprofit organizations shall be limited to three (3) signs per event and the signs shall not exceed 90 days per calendar year.

Signs may not be placed in any right-of-way and must be located on an approved surface; not including fire lanes and/or circulation drive lanes. (*Asphalt, concrete, class-5 and crushed concrete are considered approved surfaces. Landscaped areas are not considered approved surfaces*)

### **Size**

Maximum sign size shall be limited to **56 square feet** and shall not exceed **9 feet** in height. Lettering shall not extend beyond the edges of the sign.

### **Required Fees:** (*payment due at the time each permit is submitted*)

All applicable fees/deposits must be included with each temporary sign permit application.

- Fee: **\$30.00** for each sign permit
- Deposit: **\$100.00** for each sign permit *The deposit shall be forfeited if the sign is placed on an unapproved surface and/or was erected past the date removed, as indicated on the permit.*

Deposit Refund requests need to be received within 30 calendar days of the "Date Removed" as indicated on permit.


